6. Business Manager Report

Lori Mochty of MMA reviewed January, 2022 state aid, millage check, checks that went out, fees, building and land contract costs, payroll, and the bank balance. All unpaid bills listed in financials. Discussion about \$100,000 grand (line 94) hoping to arrive in March. Discussion of 11(t) grant. Debbie Prentiss stated not yet applied for. Application comes out March 15, 2022. Grant purpose is to help remediate gaps in learning. It may have a timeframe to use. Have to continue "maintenance of effort".

Debbie Prentiss explained a resolution was needed to enter into purchasing the building. No mortgage/no approval. Appraisal was to be 2/18/22; however, school closed due to bad weather. Center Line's appraisal was at \$1,000,000; Debbie and Mark

Prentiss' appraisal was at \$575,000. The building has to appraise for 70% value of the loan or \$890,000 per Mark Prentiss or Huntington Bank will not do the loan. Center Line would not authorize for residential purposes, only for a school; however, size and demographics of lot prohibits many being interested. Bob Nowak asked if board wants to commence with refinance. Debbie Prentiss stated that the appraisal will cost \$3,000. The board voted to support the continuation of the process for the resolution authorizing issuance of refunding bond.

Debbie also discussed that she asked for approval of, and was granted, renting goats to consume the thistle in the garden.
